Take the Survey

We are nearing the time for the Citizens Water and City of Westfield Sewer Project to begin. This project will run new piping in Willow Creek on the east side of Cool Creek from SR32 to a location north of the community on Grassy Branch. This will provide the services necessary to support the new community (The Lakes at Grassy Branch) being built on the north end of Grassy Branch. They are slated to begin

digging the trenches to lay the pipe early spring, 2015 and only expect

the project to take a few weeks.

For those residents of the Grassy Branch side of our community, you will see trucks and workers behind Shaelynn Court and Grandview Way. Please ensure that you remove all items from the HOA property adjacent to the creek by the end of February to ensure they are not damaged by the construction crews. They have advised the HOA Board that most of the piping will be laid in open area between your houses and the tree line of the creek.
